

Strategy Overview

The Cambria Trinity ETF (TRTY) seeks income and capital appreciation from investments in exchange-traded vehicles that provide exposure to the major asset classes in the various regions, countries and sectors around the globe. The fund employs a balanced, systematic approach to asset allocation, focusing on diversification, value investing, and trend following. The Cambria Trinity ETF uses a buy and hold strategy that aims to produce a balanced, low-turnover portfolio of investable assets.

Fund Description

The Cambria Trinity ETF (TRTY) targets investing in ETFs that provide exposure to global stocks, bonds, and real assets. Additionally, the strategy incorporates tilts toward value and momentum investments, and trend following. TRTY has no management fee, and a 0.46% expense ratio (pass-through from underlying ETFs), allowing the cost-conscious investor to hold a diversified, low-cost global asset allocation portfolio with a moderate risk profile.

Buying and selling shares will result in brokerage commissions. Brokerage commissions will reduce returns.
